1 Applicability

1. 2 Agreement

 Once you have registered for the meeting, you will receive confirmation about your registration by email.

3 Cancellation

- 1. Only written cancellations can be accepted, to be sent to RAFA2019@vscht.cz.
- 2. Cancellation of participation in the conference: Cancellation before September 1, 2019 – refund 75%; no refunds after that date.

Where an individual fails to attend and has not cancelled in advance, the full conference costs are also payable.

It is acceptable to send a substitute to the meeting.

4 Changes to the program, location of the conference

- Where there is good reason to do so, the organizer is entitled to change the location of the conference. Attendees will then be permitted to withdraw.
- 2. Where there is good reason to do so, the conference may be cancelled; any charges that have already been paid will be refunded. No claims for compensation above and beyond this will be valid.
